I acknowledge that at all times, I am a volunteer for the 2020 Insuperity Invitational, and I am not acting as an employee of the Insuperity Invitational, Insuperity, UnitedHealthcare, Greater Houston Golf Charity, Inc., The Woodlands Country Club Tournament Course, Sequoia Golf Woodlands LLC and its affiliates, Pro Links Sports, PGA TOUR Inc., Professional Golfers Association of America, PGA/PGA TOUR Properties, Inc.; and such other entities as Greater Houston Golf Charity may reasonably designate. I further acknowledge I shall not be entitled to participate in and benefit from any employee benefit or welfare plans, including but not limited to employee health or liability insurance. I understand that Greater Houston Golf Charity presently provides limited insurance benefits in the event I sustain any injuries or damages incident to such volunteering and that I will immediately contact the tournament office for proper processing instructions relative to any injury or damages.

Pursuant to my participation as a volunteer for the 2020 Insuperity Invitational, I recognize that there are certain risks and possible bodily or personal injuries and damages that one may sustain through such participation, including but not limited to the following:

- (i) being struck by a golf club or an errant or misdirected golf ball;
- (ii) being struck by a golf cart or other vehicle;
- (iii) falls due to unevenness of terrains or surfaces;
- (iv) injuries arising from sports, physical exertion, or outside activities;
- (v) injuries arising from lightning, heat, cold, rain or other weather related factors;  
and
- (vi) any other injuries or damages I may sustain as a volunteer.

**INTEGRITY PROGRAM:** The PGA TOUR Integrity Program is intended to maintain integrity and prevent betting-related corruption in PGA TOUR competitions. Each volunteer is subject to the terms of the PGA TOUR Integrity Program Manual (the "Integrity Program Manual"). The Integrity Program Manual, among other things: prohibits volunteers from betting on the Tournament and providing inside information to third parties for purposes of betting on the Tournament; and requires volunteers to report any violations of the Integrity Program Manual to the TOUR. A violation of the Integrity Program may result in dismissal from volunteering for the Tournament, among other consequences.

This Acknowledgement, Release, Waiver and Hold Harmless Agreement shall be binding upon me and my heirs, assigns and legal or personal representatives.
