This email is your official invitation to join the fantasy challenge, whereby top-performing teams will win charitable donations for their designated charity.

## **RULES & GUIDELINES**

To enter the Insperity Invitational \$50,000 Corporate Charity Challenge, please complete the form where you will select a charity and your team.

- Step 1:** Select a local 501c3 non-profit organization that resides in Harris or Montgomery County, Texas.
- Step 2:** Select a team. Please choose your eight-man roster of PGA TOUR Champions players to serve as your fantasy team for the duration of the Insperity Invitational Corporate Charity Challenge season.

## **FANTASY TEAMS**

Fantasy Teams will be comprised of PGA TOUR Champions players who finished in the top 54 in Prior Year Charles Schwab Cup Points and active PGA TOUR Champions players in the top 150 All-Time Money not otherwise in the top 54 Prior Year Charles Schwab Cup Points. One player will be selected from each of the following groups:

Group 6 / 1-47 All-Time Money*	1
Group 7 / 48-150 All-Time Money*	1
Group 8 / WILD CARD / Top 150 All-Time Money*	1

\*All-Time Money – Players in this category are in the top 150 All-Time Money, did not finish in the top 54 in Prior Year Charles Schwab Cup Points, and are active on the PGA TOUR Champions.

Players who do not play in an event or withdraw prior to competition, will not receive any points.



## **CHARITY ALLOCATIONS**

Each weekly winner will receive a \$1,000 donation to be given at the end of the 2025 PGA TOUR Champions season.

26 events - \$26,000

Charitable Funds for Season-Long Standings (Top Overall Finishers):

First Place - \$10,000

Second Place - \$8,000

Third Place - \$6,000

If two or more teams tie for a weekly or season-long prize, they will share in the funds equally.

**Deadlines: Submissions are welcome immediately and are due NO LATER than Thursday, February 13, 2025, to be eligible for all tournaments beginning with the Chubb Classic (February 14-16). Thereafter, your initial submission must be received the Thursday prior to the competition to be scored for that tournament week. Entries will be accepted up to March 20, 2025.**

## **RESULTS**

The Tuesday after the event, tournament results will be emailed to the contact listed on your registration. The results will also include the season-long standings.
